DATE: February 25-27, 2011

LOCATION: University of Wisconsin-Madison Natatorium; 2000 Observatory Drive, Madison, WI 53707
See maps at www.badgeraquatics.com. No entry into the building before 6:30 AM on Saturday and Sunday

FACILITY: An 8-lane, 25-yard pool with a starting and turn depth of 4-½ feet. It has regulation-height starting blocks (30") and an ample viewing area for athletes and spectators. Specifications: The Competition Course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

CLASSIFICATION: State Championship Time Standards, Wisconsin LSC-dictated (5 10-U girl's, and 2 11-12 girl's event qualifying times have changed since 2010)

TENTATIVE SCHEDULE: The timeline listed below is an approximation. The exact timeline will be posted on www.wisconsinswimming.org after all entries have been received. All are at the meet management's discretion.

WARM-UPS: There will be assigned times and lanes for the morning warm up session; there will be three 30 minute sections to each AM session. The warm up schedule will be posted on the Wisconsin web: www.wisconsinswimming.org. The afternoon sessions will not be assigned and will be general warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lanes will be opened & closed as necessary by the Meet Director. The NO Diving and **Feet First entry into the pool during general warm-ups will be enforced for all sanctioned/approved competition.** Swimmer(s) without a coach present are to report to the Meet Director prior to warm-up for lane assignment.

ENTRIES: Swimmers may compete in **FIVE** individual events per day plus relays up to a maximum of **SEVEN** individual events for the meet. This meet and the 13 & Over State meet are under separate sanctions. Qualified swimmers may compete in both meets up to each meet's maximum allowable entry. Swimmers must be registered USA Swimming athletes with their age as of February 25, 2011.

ENTRY DEADLINE: Entries **must** be **e-mailed** to swimbac@gmail.com by **5:00 pm on Monday, February 21, 2011**. This entry must include all additional qualifiers from the previous weekend's regional meets. No changes will be allowed to your entry after the entry deadline has passed. You will receive a confirmation e-mail. If you have not received your confirmation by Tuesday AM, call Drew at (608) 698-5995 immediately.
****Per the Age Group committee ruling; all teams are required to submit entries in the Hy-Tek commlink or SD3 format. Additional relay only swimmers will be accepted as a deck entry. Relay only swimmers must be deck entered no later than 20 minutes before the start of each session.**

Your completed entry form, signed waiver, and entry fees must be received by **Wednesday February 23, 2011**. If you send it by overnight mail please waive signature requirement on your overnight package. A psych sheet will be posted by 5:00 pm on Tuesday the 22nd on the Wisconsin LSC web. If there are any meet management errors with your entry, you must contact Drew Walden by **Wednesday, February 23 by 9:00 am** to correct any errors. No changes will be allowed, only corrections due to meet management errors. No additional entries will be accepted, so please review your entries carefully before e-mailing them on Monday. The meet will be run on Hy-Tek's Meet Manager.

BONUS EVENT: **ONE bonus event is allowed for any swimmer who is entered into the meet with a verifiable individual swim, but not to exceed 7 individual events.** Swimmers should enter their bonus event at their best time or NT (if no seed time in that event). Bonus swims will be seeded in the earliest heats. There is no bonus swim for swimmers that are: relay only entrants into the meet.
Swimmers are only allowed ONE bonus event for the meet! *Please note: Bonus events should be included in your Hy-Tek file and tagged as a bonus event. Also include a complete list of your bonus events for your team in your entry e-mail on February 21st.** A swimmer may enter any event as a bonus race.

RELAY ENTRIES: Teams may enter an "A" relay regardless of athlete count. In order for a team to enter a "B" relay, the team must have at least 5 individual qualifiers in that age group/gender. For example: your team has (5) 10 & under boys qualified for the meet. Your team is allowed an A and a B relay for all 10 & under boy relays. If you have 9 athletes in that age group/gender, you can add a "C" relay, and so on.

ENTRY FEES: \$3.00 LSC Splash Fee Per Swimmer
\$5.00 per individual event
\$16.00 per relay - Please note: Relay-only swimmers MUST also pay the \$3.00 LSC splash fee.

TIME STANDARDS: Swimmers must meet 12 & Under State Championship qualifying times as set by Wisconsin Swimming, which are available at www.wisconsinswimming.org.

PROOF OF TIME: Swimmers who fail to achieve the meet time standard or are disqualified from an individual event in a non-bonus event, are required to prove their time with a viewable meet result or the SWIMS Database or pay a \$50 fine. Entry times submitted by the initial deadline will be verified through USA SWIMS database. Additional entries, submitted after the initial deadline, will not be verified through the USA Swimming SWIMS database. Time trials or relay leads from this meet will not be accepted for proof of time. Proof must be provided, or fine paid, before the start of the next session. All proofs must be completed by the conclusion of Sunday's events. There will be no refunds for proofs after that time. Proof of time will be accepted at the meet management office.

SCRATCH RULE: ***Pre-seeded Events***

- Each swimmer shall report promptly to the starting blocks prior to the start of each race in which the swimmer is entered.
- Any swimmer not reporting for or competing in an individual timed final event shall not be penalized.
- Any swimmer not reporting for or competing in a preseeded preliminary heat when finals are scheduled shall not be penalized.

Events Seeded on the Deck

- Any swimmer entered in an individual event that is seeded on the deck, who has checked in for the event, must swim in the event unless the swimmer notifies the clerk of course before the seeding for that event has begun that the swimmer wishes to scratch.
- Checked in swimmers failing to compete will be barred from the next individual event in which the swimmer is entered on that day or the next meet day, whichever is first.
- A swimmer may "declare a false start" with the Deck Referee prior to the start of their heat, and not incur a penalty.
- Events seeded on the deck shall be closed for seeding according to the schedule in this meet information.

POSITIVE CHECK-IN: This meet is pre-seeded. All swimmers must report to their blocks for the start of their heat with the exception of the 1000 Freestyle, which will be a positive check-in event. Positive check-in will close 30 minutes prior to the start of the session. ****The 1000 Free will swim Fastest to Slowest alternating girl's heats with boy's heats.**

DECK ENTRIES: Deck entries for individual events will not be accepted. Relay only swimmers can deck enter no later than 20 minutes before the start of each session. The coach must give the information to the Meet Director and pay the appropriate fee(s). Deck USA Registrations will not be accepted.

DISABILITY SWIMMERS: Please indicate on the entry form any special needs for those athletes requiring assistance. Also, please inform the **Meet Referee** of those needs prior to the start of the meet.

Awards: ***No awards will be mailed! (Awards not picked up at the meet will be brought to the April LSC meeting.)***

Individual Awards: Medals: 1st – 8th, Ribbons: 9th – 16th

Relays: Medals: 1st – 3rd, Ribbons: 4th – 8th

State Championship t-shirt will be awarded to the winner in each event. (Limit one per swimmer.)

Individual High Point: 1st – 3rd male and female-- No Team Divisions for these awards.

Women's & Men's Age Group Team Awards: 1st – 3rd ---No Team Divisions for these awards.

Team Awards: Team awards for total point accumulation will be awarded in two (2) divisions. The top 5 teams in each division will be awarded team awards. Division seeding and information can be found online at www.wisconsinswimming.org. Breaks for awards presentations will be determined once a meet timeline has been generated. The meet timeline will be posted online as soon as it is determined.

SCORING: Individual Events: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1
Relay Events: Double Points

COACHES: Meet packets can be picked up inside of the pool office. Coaches must show a valid USA Coaches Registration card when checking in, and **all coaches must have a visible valid coach's card to be on deck**. Meet officials will be checking coach's cards during the meet. There will be a brief coaches meeting before the start of each day's meet. Meeting location will be announced during warm-ups.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

OFFICIALS: The Meet Referee: Ben Radloff (BAC). Head Chief Judge: Richard Potter (DFAC). All Officials must have a visible and valid USA Swimming registration card, and must be working that session to be on the deck.

MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director, Meet Marshall or Meet Referee, is harmful to others or to other's property will be required to leave the competition. The use of cell phones and recording devices are strictly forbidden in the locker rooms. Meet Marshal will periodically inspect the locker rooms for compliance.

ADMISSIONS: There will be no charge for admission.

HEAT SHEETS: \$25.00 for the whole meet sheet packet.
