## 12&Under State Meet Important Changes.

Please take a moment to review the following changes in the conduct of the 12&Under State Meet. The following changes are listed in the meet information letter.

- Change to Relay Only Swimmers procedure. In order for teams to have a relay, each team must have at least one swimmer with an individual state qualifying in the respective age group/gender. Teams are allowed to use Relay Only Swimmers only to fill "A" relays.
- Change to Bonus Event procedure. Swimmers with ONE state cut are allowed to swim TWO bonus events, swimmers with TWO state cuts are allowed to swim ONE bonus event and any swimmer with THREE or more state cuts is NOT allowed any bonus swims.
- **Proof of Time fine is \$200:** The fine for failing to prove that a swimmer has achieved the qualifying time in an event where the swimmer has failed to swim under the cut has been raised from \$50 to \$200.
- Submission of List of Bonus Entries: All teams must submit a hard copy of their bonus entries prior to the entry deadline. Teams may submit their bonus list as an attached scan with their email entry, mailed in time to arrive prior to the deadline or via the electronic form soon to be available on the Wisconsin Swimming Website (<a href="www.wisconsinswimming.org">www.wisconsinswimming.org</a>).
- Submission of Waiver Form: All waivers must be received by the entry chair no later than <a href="https://doi.org/11.59">11:59</a>
  <a href="https://doi.org/10.50/">PM Wednesday, February 22nd, 2012</a>, or be subject to a \$200 fine from the LSC. Teams may submit their waiver as an attached scan with their email entry, mailed in time to arrive prior to the deadline or via the electronic form soon to be available on the Wisconsin Swimming Website (<a href="https://www.wisconsinswimming.org">www.wisconsinswimming.org</a>).

FACILITY: An 8-lane, 25-yard pool. Pool depth is 13 feet at the start end and 5'10" at the bulkhead. Blocks are 30" high.

The pool features a 9'13" full color, digital display scoreboard. Concessions will be available. No food or beverage is

allowed in pool area. The competition course has not been certified in accordance with USA Swimming's

Rule 104.2.2C(4).

CLASSIFICATION: State Championship Time Standards, Wisconsin LSC-dictated (11-12 girls 200 back and breast updated times

from September, 2011 will be used)

SCHEDULE: after all entries have been received. All are at the meet management's discretion.

WARM-UPS: There will be assigned times and lanes for the morning warm up session; there will be three 30 minute sections to

each AM session. The warm up schedule will be posted on the Wisconsin web: www.wisconsinswimming.org. The afternoon sessions will not be assigned and will be general warm-ups/circle swimming in all lanes for each warm-up

session. Push-pace and sprint lanes will be opened & closed as necessary by the Meet Director.

The NO Diving and Feet First entry into the pool during general warm-ups will be enforced for all sanctioned/approved competition. Swimmer(s) without a coach present are to report to the Meet Director prior

to warm-up for lane assignment.

**DEADLINE:** 

ENTRIES: Swimmers may compete in **FIVE** individual events per day plus relays up to a maximum of **SEVEN** individual events

for the meet. This meet and the 13 & Over State meet are under separate sanctions. Qualified swimmers may compete in both meets up to each meet's maximum allowable entry. Swimmers must be registered USA Swimming

athletes with their age as of February 24, 2012.

ENTRY Entries must be e-mailed to michael@waukeshaexpress.org by 5:00 pm on Monday, February 20th, 2012

This entry must include all additional qualifiers from the previous weekend's regional meets. No changes will be allowed to your entry after the entry deadline has passed. You will receive a confirmation e-mail. If you have not

received your confirmation by Tuesday AM, call Michael at (262) 309-2776 immediately.

\*\*Per the Age Group committee ruling; all teams are required to submit entries in the Hy-Tek commlink or SD3 format. Additional relay only swimmers will be accepted as a deck entry. Relay only swimmers must be deck entered

no later than 20 minutes before the start of each session.

Your completed entry form, signed waiver, and entry fees must be received by **Wednesday February 22, 2012**.

If you send it by overnight mail please waive signature requirement on your overnight package.

A psych sheet will be posted by 5:00 pm on Tuesday the 21st on the Wisconsin LSC web. If there are any meet management errors with your entry, you must contact Michael Hamm by **Wednesday, February 22nd by 9:00 am** to correct any errors. No changes will be allowed, only corrections due to meet management errors. No additional entries will be accepted, so please review your entries carefully before e-mailing them on Monday. The meet will be

run on Hy-Tek's Meet Manager.

BONUS EVENT: Swimmers with one state cut, will be allowed two bonus events. Swimmers with two state cuts, will be allowed one bonus event. Swimmers with three or more bonus events, will not be allowed a bonus event.

Swimmers should enter their bonus event at their best time or NT (if no seed time in that event). Bonus swims will be seeded in the earliest heats.

\*\*\*Please note: Bonus events should be included in your Hy-Tek file and tagged as a bonus event. **Also include a complete list of your bonus events for your team in your entry e-mail on February 20<sup>th</sup>.** A swimmer may enter any event as a bonus race.

RELAY ENTRIES: Teams must have at least one swimmer qualified in a respective age group in order to have a relay in the same age

group. Teams are allowed to use relay only swimmers to fill only "A" relays. In order for a team to enter a "B" relay,

the team must have at least 8 individual qualifiers in that age group/gender.

**ENTRY FEES:** \$2.00 LSC splash fee per swimmer

\$5.00 per individual event

\$16.00 per relay - Please note: Relay-only swimmers MUST also pay the \$2.00 LSC splash fee.

TIME

Swimmers must meet 12 & Under State Championship qualifying times as set by Wisconsin Swimming, which are

STANDARDS: available at www.wisconsinswimming.org.

PROOF OF TIME:

A swimmer who does not swim equal to or faster than the Meet qualifying time standard, or is disgualified from an individual event, must prove his/her time, i.e., must provide documentation that he/she has swum at least as fast as the entry qualifying standard, or pay a penalty/fine in the amount of \$200.

Acceptable proof of time for a WI LSC Championship Meet must be from a meet that identifies the swimmer by name, his/her time, and the meet name and date at which the swimmer previously achieved the qualifying time. Examples include the USA Swimming SWIMS database, from any USA sanctioned, approved or observed meet, WIAA high school meets, YMCA closed competition, and NCAA closed competition meets. The result of a Time Trial, conducted at this meet is not acceptable.

Outstanding proofs of time and fines must be taken care of prior to the end of the meet.

#### SCRATCH RULE:

#### **Pre-seeded Events**

- Each swimmer shall report promptly to the starting blocks prior to the start of each race in which the swimmer is entered.
- Any swimmer not reporting for or competing in an individual timed final event shall not be penalized.
- Any swimmer not reporting for or competing in a preseeded preliminary heat when finals are scheduled shall not be penalized.

#### **Events Seeded on the Deck**

- Any swimmer entered in an individual event that is seeded on the deck, who has checked in for the event, must swim in the event unless the swimmer notifies the clerk of course before the seeding for that event has begun that the swimmer wishes to scratch.
- Checked in swimmers failing to compete will be barred from the next individual event in which the swimmer is entered on that day or the next meet day, whichever is first.
- A swimmer may "declare a false start" with the Deck Referee prior to the start of their heat, and not incur a
- Events seeded on the deck shall be closed for seeding according to the schedule in this meet information.

**POSITIVE** CHECK-IN: This meet is pre-seeded. All swimmers must report to their blocks for the start of their heat with the exception of the 1000 Freestyle, which will be a positive check-in event. Positive check-in will close 30 minutes prior to the start of the session. \*\*The 1000 Free will swim Fastest to Slowest alternating girl's heats with boy's heats.

DECK ENTIRES: Deck entries for individual events will not be accepted. Relay only swimmers can deck enter no later than 20 minutes before the start of each session. The coach must give the information to the Meet Director and pay the appropriate fee(s). Deck USA Registrations will not be accepted.

DISABILITY SWIMMERS: Please indicate on the entry form any special needs for those athletes requiring assistance. Also, please inform the **Meet Referee** of those needs prior to the start of the meet.

#### No awards will be mailed! (Awards not picked up at the meet will be brought to the April LSC meeting.)

State Championship t-shirt will be awarded to the winner in each event. (Limit one per swimmer.)

Individual High Point: 1<sup>st</sup> – 3<sup>rd</sup> male and female-- No Team Divisions for these awards. Women's & Men's Age Group Team Awards: 1st - 3rd ---No Team Divisions for these awards.

Team Awards:

Team awards for total point accumulation will be awarded in two (2) divisions.

The top 5 teams in each division will be awarded team awards. Division seeding and information can be found online at www.wisconsinswimming.org.

Breaks for awards presentations will be determined once a meet timeline has been generated. The meet timeline will be posted online as soon as it is determined.

SCORING: Individual Events: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1 Relay Events: Double Points

COACHES: Meet packets can be picked up inside of the pool office. Coaches must show a valid USA Coaches Registration card

when checking in, and **all coaches must have a visible valid coach's card to be on deck**. Meet officials will be checking coach's cards during the meet. There will be a brief coaches meeting before the start of each day's meet.

Meeting location will be announced during warm-ups.

OFFICIALS: The Meet Referee: Patrick Wieisling- SHOR. Head Chief Judge: Kim Stoll-LAKE. All Officials must have a visible and

valid USA Swimming registration card, and must be working that session to be on the deck.

MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director, Meet

Marshall or Meet Referee, is harmful to others or to other's property will be required to leave the competition. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or

locker rooms. Meet Marshal will periodically inspect the locker rooms for compliance.

ADMISSIONS: \$5.00 per session. There will be the option to purchase admission for all sessions and all heat sheets for \$30.00

HEAT SHEETS: \$3.00 per session.

PARKING: The Waukesha South High School parking lot will be available all weekend for parking.
