

**Waunakee Orcas of Wisconsin

- Sanction #:** WI2012-125S
- Location:** Waunakee HS Pool, 100 School Dr., Waunakee, WI 53597
- Facility:** Eight lanes, 25 yards flush deck, non-turbulence lane dividers and backstroke flags, with 18" height starting blocks. Pool is 7.5 feet deep at the starting blocks and 3.5 feet deep at the non starting end of the pool.  
**The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).**  
**100 yard relays will have the 2<sup>nd</sup> and 4<sup>th</sup> leg of the relay start in the water.**
- Timing:** Colorado System 5 with backup watches. All events are timed finals. Computerized score board for all lanes.
- Officials:** Meet Referee: **Don Heinz**  
There will be at least three certified USA Swimming Officials on deck at all times.
- Rules:** Current USA Swimming and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA Swimming. Events/heats may be combined as directed by the Meet Referee during the meet and by Meet Director for pre-meet seeding. Breaks may be added if need is determined by Meet Referee.
- Check-ins:** Open 400 IM, Open 1000 Freestyle, Open 500 Freestyle and Open 1650 Freestyle will be positive check-in events. Check-in with clerk of course. Check-in will close 30 minutes prior to the start of the session in which the event is contested. Heats may be limited for these events. A swimmer who checks-in and fails to swim in his/her individual checked-in event is barred from his/her next individual event.
- Warm-ups:** Friday pm warm-ups are 6:00-7:00 pm with competition starting at 7:10 pm. Saturday am warm-ups are 7:00-8:00 am with competition starting at 8:10 am. A 20 minute warmup for the Saturday Session 2, 500 events, will begin immediately following the Sat. AM session, but not before 10:30 AM. Saturday pm warm-up session will begin not sooner than 11:30 AM or 10 minutes after the completion of Session 2 and will last 60 minutes with competition starting 10 minutes after the end of warm-ups. Sunday pm warm-ups are 10:50-11:50 am with competition starting at 12:00 pm.
- All lanes open for circle swim for the first 30 minutes; sprint lanes open for second 30 minutes in lanes one and eight with the other lanes remaining open for circle swim. Team lane assignments will be available in the coaches' packets. "SIT AND SLIDE ENTRY" or "THREE POINT ENTRY" ONLY. Meet Marshals will be on deck during the entire warm-up, with the authority to recommend disqualification. Session time line and psych sheet will sent to the email address submitted with the registrations when available.

**Entries/Deadline:** Swimmers may compete in 4 individual events per day and 2 relays. All teams are requested to submit entries in the Hy-Tek Commlink format. Emailed **Hy-Tek Entries are due Tuesday, January 17, 2012**. You will receive an e-mail confirmation of your entry within 48 hours. If you have not received that confirmation, please call Jill Maxfield at 608-849-5098. A check for meet entry fees, a hard copy of the entry fee remittance, and signed waiver may be sent via standard mail and postmarked by Tuesday, January 17, 2012. ***For entries NOT submitted by Hy-Tek Commlink; hard copy, waiver and fees, must be received by Friday, January 6, 2012.***

**Entry Fees:** \$2.00 LSC splash fee per swimmer, \$4.00 per individual event, and \$12.00 per relay

**Deck Entries:** The entry fee for deck entries will be \$5.00 (\$15.00 for relays) in addition to the \$2.00 entry fee (\$12 for relays). Deck entries will be allowed to fill open lanes. No additional heats will be added. Deck seeding will close 30 minutes prior to the start of each session.

**Deck USAS Registration** WOW will not accept deck USAS registration. An unregistered swimmer may not compete.

**Age Groups:** 6 and under, 7-8, 9-10, 11-12, 13-14, Senior (15-18)  
Age as of the first date of the meet.

**Awards & Scoring:** Individual Events, places 1<sup>st</sup> thru 16<sup>th</sup>: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1  
Relay Events, places 1<sup>st</sup> thru 8<sup>th</sup>: 40, 34, 32, 30, 28, 26, 24, 22, 18, 17, 12, 10, 8, 6, 4, 2

Awards for relay events will consist of ribbons for 1<sup>st</sup>-8<sup>th</sup> place. Awards for individual events will consist of ribbons for 1<sup>st</sup>-16<sup>th</sup> place. Coaches will be permitted to pick up awards at the end of each session. Awards will not be mailed.

**Coaches:** All coaches can pick up their coaches packets in the pool office. Coach USAS membership cards will be check at that time. A Meet Marshal will check other coaches' USAS membership cards during the Meet. Entry changes are due in writing on Computer Change forms provided to the clerk of course in the pool office 30 minutes prior to the start of each session.

All teams are responsible for the conduct of their swimmers. The Meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
