SENIOR DEVELOPMENT COMMITTEE MEETING

- Looking at making Jr. Nationals a special meet with awards and accolades
- Look at making summer Sr. Nationals a GOLD standard meet
 - o Qualify only LCM
 - Making standards harder to make it the "finest of the finest"
 - o A/B finals and eliminating C Finals
- Has not really looked forward to the short course/winter meet schedule

NATIONAL YOUTH TEAM – Jack Roach

• Brief report on the past National Jr. Team

NATIONALS

- Recommendations from the Steering Committee regarding Nationals
 - Elimination of Yard time for LC Nationals = motion made, seconded and passed.
 - A/B Finals and C Finals but ONLY 18/Under athletes with 19/O athletes filling that C Finals heat only as needed = motion made, seconded and passed.
 - o Relay standard failed
 - Elimination of relay-only athletes from time trials failed.

DECK PASS PROJECT

 Linked thru USA Swimming – allowing an athlete/non-athlete to show accolades and be awarded patches for achievements. Coaches are allowed to earn and give away patches. Similar to facebook with friending on Deck Pass.

TIME STANDARDS:

• Right now the SR National cuts are faster than the Olympic Trial cuts going into 2012. Motion to use the Trial cuts for US Open for 2012 passed.

LSC DEVELOPMENT COMMITTEE MEETING

LEAP – Streamlining the process with moving items on the USA Swimming website to allow LSCs to utilize a check box for items that don't require supporting documents. The Committee saw many problems with asking the LSCs for too much information and simplify the process by asking the LSC to simply state that they comply with specific items (i.e. having the LSC check that they comply with State and local laws and not have them produce proof of such).

The changes for LEAP will be effective January 1^{st} , 2012. Need to remind LSCs that even if they have passed Level 1 – after January 1^{st} , 2012 they need to go back and redo the items and repass Level 1.

The new LEAP website will have examples of supporting documents needed.

WORKSHOP – looking at supporting another Leadership Workshop in October 2012 for the General and Administrative Chairs from each LSC. Look at grouping Zones together so that each Zone can work together to their benefit.

KIDS INITIATIVE

- Representatives from FINA, ACSA, High School Federation, US Masters, USO/Parolympics, NCAA and YMCA meet
 at each USAS Convention and work together to unify the different divisions of swimming. This has been a 10year project to try to bring all groups involved in swimming together.
